Dear Antonio, Ryan, and the Segway and Metro Mobility Teams

I trust this message finds you well. I hope to convey our immense excitement about our collaborative efforts in bringing micromobility solutions to Mozambique. It's been a transformative journey, and as we progress toward the deployment of our shared mobility service, I wanted to provide an update and inquire about the status of our earlier request.

We've been diligently preparing for the deployment of our e-scooters, focusing on integrating payment systems with <u>Local Financial Operators in Mozambique and VISA</u>, already working with the operators to ensure a seamless, inclusive and accessible experience for our users.

Furthermore, to guarantee a secure operational framework, we've contracted civil liability insurance for activities, drivers, and equipment with ARKO Seguros (www.arkoins.com) and are on the verge of securing the supply of batteries alongside respective solar panels from FUNAE (www.funae.co.mz), a huge step toward sustainable energy usage in the industry.

To fortify our operational backbone, we've secured a fleet of 8 operational cargo-trucks (commercial tuk-tuks) vehicles from our partner in China, who's been our strategic partner for the past 4 years in Mozambique (www.dayangnaki.com). This partnership will enable us to efficiently manage teams on the field and redistribute our e-scooter fleets across our operational zones.

However, our progress in acquiring an appropriate photovoltaic system from FUNAE hinges on the technical specifications of the charging stations, which we eagerly await from your teams. These specifications are integral to aligning our charging infrastructure with sustainable energy solutions.

Simultaneously, we've initiated collaborations with an extensive network of hotels, shopping malls, university campuses, corporate and financial buildings, supermarkets, metropolitan residential neighborhoods, cinemas and theaters, travel agencies, restaurant chains, and public institutions for the concession and rental of spaces for the installation of the charging stations, as well as contact with commercial entities (restaurants, pharmacies, butchers, convenience stores, liquor stores, pet shops, flower shops, grocery stores, etc.) for registration on the delivery platform underconstruction and respective acquisition of computer equipment integrated into the order and delivery registration system.

Moreover, recognizing the significance of brand visibility, we've initiated requests for merchandising, placing an initial order for 1000 branded Helmets, 750 branded Jackets, 450 branded Polos, and 500 branded Backpack Delivery Bags for TXAPITA Food. 
